**REQUEST UNDER THE FREEDOM OF INFORMATION ACT 2000 Ref No: FOI2018/03451**

I write in connection with your request for information received on 25th June. I note you seek access to the following information:

**Of the following offences resulting in an arrest in the last three financial years how many refer to the involvement of so-called 'paedophile hunting groups' (also known as 'anti-paedophile activist groups, or 'vigilante anti-paedophile groups'), and of these in how many is the arrested individual known to have gone on to take their own life if held? ADULT ATTEMPT TO MEET A BOY UNDER 16 YEARS OF AGE FOLLOWING GROOMING ADULT ATTEMPT TO MEET A GIRL UNDER 16 YEARS OF AGE FOLLOWING GROOMING ADULT MEET A BOY UNDER 16 YEARS OF AGE FOLLOWING GROOMING ADULT MEET A GIRL UNDER 16 YEARS OF AGE FOLLOWING GROOMING ATTEMPTING TO ENGAGE IN SEXUAL COMMUNICATION WITH A CHILD ENGAGE IN SEXUAL COMMUNICATION WITH A CHILD**

I am required by the Freedom of Information Act 2000 (The Act) to handle all requests in a manner that is blind to the identity of the requestor. Any information released in response to a request is regarded as being published and therefore, in the public domain without caveat.

Following enquiries within the Constabulary please see our response below.

**Response** – Any information received via a telephone call to the Force Control Centre would be recorded in our Incident Management System. Over the last five years there were over 1,500 logged records which included the words Paedophile, Pedophile or Paedo, the details of these entries would have to be read individually to ensure that the information related to such groups.

Unfortunately this means it is not possible to suggest a way to refine this request, as even if the date range were reduced it would still require hundreds of records to be manually checked.

We therefore, consider that the cost of complying with your request for information would exceed the appropriate limit of £450 as has been stated in the Freedom of Information (Fees & Appropriate Limit) Regulations 2004.

Section 12(1) of the Freedom of Information Act 2000 provides that –  
*“Section 1(1) does not oblige a public authority to comply with a request for information if the authority estimates that the cost of complying with the request would exceed the appropriate limit.”*

Section 17(5) of the Freedom of Information Act 2000 requires Hertfordshire Constabulary, when refusing to provide such information (because the cost of compliance exceeds the appropriate limit) to provide you the applicant with a notice which states that fact.

In accordance with the Freedom of Information Act 2000 this letter acts as a Refusal Notice under Section 12 of the Freedom of Information Act.
