REQUEST UNDER THE FREEDOM OF INFORMATION ACT 2000 Ref No: FOI2018/05655

I write in connection with your request for information received on 8th October. I note you seek access to the following information:

Please can you tell me -

- **On how many occasions since body worn video has been introduced at your police force have there been faults with the system e.g. cameras not working as they should, problems with downloading the footage. Please specify the nature of the fault in each case and include any comments an officer has made about the incident**
- **Please tell me on how many occasions body worn video has been deployed and how many body worn cameras the force has. Please also state how much the force has spent on body worn cameras**
- **Please tell me on how many occasions body worn video footage or the camera has been lost**

I am required by the Freedom of Information Act 2000 (The Act) to handle all requests in a manner that is blind to the identity of the requestor. Any information released in response to a request is regarded as being published and therefore, in the public domain without caveat.

Following enquiries within the Constabulary please see our response below.

Response – Hertfordshire Constabulary does not centrally record usage, faults or loss of body worn video. Therefore we have had to conduct a manual search for the information requested which has exceeded the 18 hour limit. Unfortunately this means it is not possible to suggest a way to refine this request, as even if the date range were reduced it would still require hundreds of records to be manually checked.

We therefore, consider that the cost of complying with your request for information would exceed the appropriate limit of £450 as has been stated in the Freedom of Information (Fees & Appropriate Limit) Regulations 2004.

Section 12(1) of the Freedom of Information Act 2000 provides that –
“Section 1(1) does not oblige a public authority to comply with a request for information if the authority estimates that the cost of complying with the request would exceed the appropriate limit.”

Section 17(5) of the Freedom of Information Act 2000 requires Bedfordshire Police, when refusing to provide such information (because the cost of compliance exceeds the appropriate limit) to provide you the applicant with a notice which states that fact.

In accordance with the Freedom of Information Act 2000 this letter acts as a Refusal Notice under Section 12 of the Freedom of Information Act.
