REQUEST UNDER THE FREEDOM OF INFORMATION ACT 2000 Ref No: FOI2018/05998

I write in connection with your request for information received on 18th October. I note you seek access to the following information:

I am writing to make an open government request for all the information to which I am entitled under the Freedom of Information Act 2000.

Please send me:

- 1) The numbers of Detectives (PIP Level 2 and above) that have left (resigned and career break) your police force. Please can you break this down year by year, 2010-2018.
- 2) The number of Police Officers who were off on 'long term sick', broken down year by year 2010-2018.

I am required by the Freedom of Information Act 2000 (The Act) to handle all requests in a manner that is blind to the identity of the requestor. Any information released in response to a request is regarded as being published and therefore, in the public domain without caveat.

Following enquiries within the Constabulary please see our response below.

Response – Hertfordshire Constabulary has conducted a search of our Human Resources Department for the information requested. Our system does not specify if an officer leaving the force was a qualified detective therefore a manual search of historical data has been conducted. This search as exceed the 18 hour limit. Unfortunately this means it is not possible to suggest a way to refine this request, as even if the date range were reduced it would still require hundreds of records to be manually checked.

We therefore, consider that the cost of complying with your request for information would exceed the appropriate limit of £450 as has been stated in the Freedom of Information (Fees & Appropriate Limit) Regulations 2004.

Section 12(1) of the Freedom of Information Act 2000 provides that -

"Section 1(1) does not oblige a public authority to comply with a request for information if the authority estimates that the cost of complying with the request would exceed the appropriate limit."

Section 17(5) of the Freedom of Information Act 2000 requires Bedfordshire Police, when refusing to provide such information (because the cost of compliance exceeds the appropriate limit) to provide you the applicant with a notice which states that fact.

In accordance with the Freedom of Information Act 2000 this letter acts as a Refusal Notice under Section 12 of the Freedom of Information Act.
