**REQUEST UNDER THE FREEDOM OF INFORMATION ACT 2000 Ref No: FOI2018/05076**

I write in connection with your request for information received on 10th September. I note you seek access to the following information:

- **Procurement records for Grayshift products such as GrayKey since the start of calendar 2018**
- **All correspondence between Bedfordshire Police and Grayshift since the start of calendar 2018. This can include emails, letters, or any other written communication.**

I am required by the Freedom of Information Act 2000 (The Act) to handle all requests in a manner that is blind to the identity of the requestor. Any information released in response to a request is regarded as being published and therefore, in the public domain without caveat.

Following enquiries within the Force please see our response below.

**Response** – Bedfordshire, Cambridgeshire and Hertfordshire work within a collaborated unit therefore tis response is on behalf of all 3 forces. For us to check with every staff member within the organisation and for them to perform a search to see if they have received unsolicited proposals and/or documents relating to purchasing products would exceed the 18 hour limit.

Unfortunately this means it is not possible to suggest a way to refine this request, as even if the date range were reduced it would still require hundreds of records to be manually checked.

We therefore, consider that the cost of complying with your request for information would exceed the appropriate limit of £450 as has been stated in the Freedom of Information (Fees & Appropriate Limit) Regulations 2004.

Section 12(1) of the Freedom of Information Act 2000 provides that –  
*“Section 1(1) does not oblige a public authority to comply with a request for information if the authority estimates that the cost of complying with the request would exceed the appropriate limit.”*

Section 17(5) of the Freedom of Information Act 2000 requires Bedfordshire Police, when refusing to provide such information (because the cost of compliance exceeds the appropriate limit) to provide you the applicant with a notice which states that fact.

In accordance with the Freedom of Information Act 2000 this letter acts as a Refusal Notice under Section 12 of the Freedom of Information Act.
